DIRECTIONS FOR USE

VIRIDIAN is compatible with most granular fertilizer materials.

Use in accordance with label instructions and/or the recommendations of a qualified individual or institution such as, but not limited to, a certified crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan.

APPLICATION RATE RECOMMENDATIONS

For nutritional maintenance, apply *VIRIDIAN* at 5-25 lbs per acre based on soil test analysis and recommendations. *VIRIDIAN* should be blended with fertilizers when possible.

For soil amending conditioning, apply *VIRIDIAN* at 25-75 lbs per acre depending on the severity of the deficiency, climate, crop, and soil type.

STORAGE & DISPOSAL
