FIRST AID

Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor, or going for treatment.

PRODUCT INFORMATION

ROVER is intended for use with products registered for agricultural, forestry, industrial, non-cropland, rights of way and other uses. **ROVER** contains a distinct, high-quality combination of methylated seed oil and silicone surfactants. **ROVER's** silicone surfactants increase spreading and wetting of the applied solution. The oil is a superior penetrant that aids certain pesticides in moving through the waxy cuticle of plants and leaves for greater activity. Use **ROVER** wherever a label calls for an MSO or MVO and allows or does not exclude the use of silicone surfactants.

DIRECTIONS FOR USE

Not for Aquatic Use

Read and follow all pesticide label directions.

Use only if a methylated seed oil and nonionic surfactant is allowed or not excluded on the label. Use caution when applying during hot, dry conditions.

If the user does not have experience with the mixture being applied, perform a jar test using the order and amounts in the mixture to determine compatibility and perform a phytotoxicity test to ensure crop safety.

Prior to mixing, fill the spray tank with half of the carrier. Start the sprayer and check to make sure that all valves and gauges work and that there is adequate tank agitation.

MIXING INSTRUCTIONS

Add pesticides and/or fertilizers as directed by the label or in the following sequence:

- (1) Micronutrients and fertilizers,
- (2) Dry flowables and dispersible granules,
- (3) Flowables,
- (4) Water soluble pesticides,
- (5) Emulsifiable concentrates.

Continue agitation and add **ROVER**. When completed, reduce agitation, and allow to mix for 1 to 2 minutes. While under minimal agitation, continue filling tank and allow to mix for 10-15 minutes prior to application.

USE RATES

Ground or Aerial: 0.5 to 2 quarts per 100 gallons or 0.125% -0.5 % v/v.

For spray rates of 1-5 gallons per acre, use 2-4 oz per acre.

High GPA Application Areas (>50 GPA)

Herbicides: 32 oz. per 100 gallons. Use up to 0.25% v/v

Insecticides, Fungicides & Miticides: 8 to 32 oz per 100 gallons. Use up to 0.25% v/v.

Fertilizers & Micronutrients: 8 to 32 oz per 100 gallons. Use up to 0.25% v/v.

If experience and field testing indicates benefit the use rate can be increased to 64 oz per 100 gallons, 0.5% v/v of the finished spray volume.

Some pesticides have stated adjuvant use rates. In all cases, the pesticide manufacturer's label should be consulted regarding specific adjuvant use recommendations and that rate followed. Do not add this product at a level that would exceed 5% v/v of the finished spray solution volume unless otherwise specified by the pesticide label.

STORAGE AND DISPOSAL

Storage: Store in a cool, dry place. Store in original container only. Do not store near fire, flame or other potential sources of ignition. Do not contaminate water, food or feed by storage or disposal of this product. **STORE ABOVE 40°F.**

Disposal: Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Dispose of contents/container according to all local, state, and national regulations.
