FIRST AID

Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor, or going for treatment.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue rinsing eye.

IF SWALLOWED: Have person sip a glass of water if able to swallow. **DO NOT** induce vomiting unless told to do so by a poison control center or doctor. **DO NOT** give anything by mouth to an unconscious person.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

IF INHALED: Move person to fresh air. If person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth to mouth, if possible.

PRODUCT INFORMATION

ORVALE is a wetting adjuvant for distributing soil-applied pesticides and nutrients in the root zone of plants. It is also an effective adjuvant when used in burndown and desiccation herbicide applications.

Improves the distribution of a tank mix solution within the soil profile.

DIRECTIONS FOR USE

ORVALE can be applied in-furrow, flood, microjet, sprinkler and other irrigation systems. It can also be applied in conjunction with most types of liquid fertilizer. In addition, it can be applied as a soil spray. Shallow seeded weeds, particularly grasses may be susceptible to escapes. **ORVALE** is best used with root-inhibiting herbicides. To reduce application trips, a foliar pesticide/desiccant can be added to an **ORVALE** tank mix. When metering **ORVALE** directly into an irrigation system by means of a metering injection pump or suction regulated line, do not connect to an irrigation system used for chemical applications or directly to a public water system without a back-siphon prevention system in place. Always connect to such systems in accordance with local and/or state regulations.

Prior to use, read and follow all directions on this label and on the label of the pesticide being used. The pesticide manufacturer's label for specific usages and restrictions have precedence over **DIRECTIONS FOR USE** referred to on this label.

APPLICATION RATE RECOMMENDATIONS

SOIL

- In-furrow at planting with soil pesticides - Use 1 to 2 pints per acre
- In pre-emergent herbicide sprays - Use 1 to 2 pints per acre
- In broadcast tank mix solutions - Use 1 to 4 pints per acre
- Chemigation: (Through irrigation systems such as drip, microjet, sprinklers or pivot) - Use 1 to 8 pints per acre

FOR GROWING MEDIA

- 8 to 64 fluid ounces per ton of media (test rates prior to use)

FOR FOLIAR APPLICATION

- Burndown and Desiccation: Use 8-64 ounces per acre
