- Side Dress or Top Dress: Apply 16 oz to 32 oz per acre. Mix with sufficient volume of water to achieve desired coverage.
- Ingredient Solutions: When treating bulk fertilizer, incorporate/blend *Revv-UP* at 0.5% to 3.5% by volume.
