Thrust® is designed to improve the efficacy of post emergence herbicides requiring ammonium sulfate. Ammonium salts reduce the antagonism of spray water with herbicides. When added at the rate of 9 pounds per 100 gallons, Thrust provides 8.5 pounds of ammonium sulfate per 100 gallons of spray solution. Thrust is a drift reduction/deposition aid. Thrust reduces spray fines and improves deposition on plant vegetation.

**NOTE:** Many factors contribute to drift, such as boom height, distance from target area, proper nozzle selection, nozzle configuration, spray pressure, temperature, wind and thermal inversion. Thrust will not eliminate all fines in all situations. Always use good judgment when spraying chemical control products.

Thrust prevents the formation of foam. Thrust has been finely milled to enhance rapid dispersion in the spray tank. Thrust contains no surfactants or wetting agents.

**USE DIRECTIONS**

Add Thrust at the rate of 9 to 17 pounds per 100 gallons of water

**IMPORTANT:** Follow these mixing procedures:

1. Fill spray tank one half full of water and begin agitation.
2. **SLOWLY** add required amount of Thrust to the water at the point of maximum agitation. Vigorous agitation is required to disperse the product. Continue agitation until Thrust is completely dissolved.
3. Continue filling while recirculating. Add herbicides and any additional adjuvants needed as directed by the label.
4. Always read and follow all label directions and observe all precautionary statements of the herbicide label.

**STORAGE AND DISPOSAL**

**STORAGE:** Store in a cool, dry place. Store in original container. Keep tightly closed. Do not reuse empty container. **DISPOSAL:** Nonrefillable container. Do not reuse or refill this container. *Completely empty bag into application equipment by shaking and tapping sides and bottom to loosen clinging particles.*

Dispose of contents/bag on-site or at an approved waste disposal facility. Offer for recycling if available or dispose of empty bag in a sanitary landfill or by incineration. Do not burn, unless allowed by state and local ordinances.
