PRODUCT INFORMATION

VINSEARI is a low pH, water soluble seaweed extract compatible with most products and fertilizers. *VINSEARI* induces tolerance in crops against abiotic stresses.

DIRECTIONS FOR USE

Apply 1 to 3 pints per acre of *VINSEARI* at planting and repeating at the early vegetative, pre-flowering, post flowering and crop fill stages. Fill half the tank with water, slowly add *VINSEARI* while stirring constantly. *VINSEARI* can be used on cereals, vegetables, tree nuts, fruit, and root crops. Avoid use during rain, wind, excessive dew and the hottest hours of the day.

A jar test is recommended before use to verify compatibility with spray chemicals. For acidic mixtures (<pH 4.0), pH adjustments may be required.

Use in accordance with label instructions and/or the recommendations of a qualified individual or institution such as, but not limited to, a certified crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan.

APPLICATION RATE RECOMMENDATIONS

Foliar Application: Use 1 to 2 pints per acre with enough water for adequate spray coverage. Apply as fine mist until foliage is wet.

Soil Application: Use 2 to 3 pints per acre by mixing *VINSEARI* with soil applied fertility, spraying or side dressing treatments. For drip irrigation, dilute 1-part *VINSEARI* with a minimum of 5 parts water before adding to supply tank. Continuous agitation is recommended.

STORAGE & DISPOSAL

Dispose of contents/container in accordance with local/regional/national regulations. Store product in original container tightly closed, upright, in a dry place. **DO NOT** store in excessive cold or heat. **DO NOT** reuse container. **DO NOT** contaminate water, food or feed by storage or disposal.
