CHE-MAGNESIUM 2.5% is fully chelated and in a form readily available to plants. **CHE-MAGNESIUM 2.5%** is compatible with most pesticides. Use the standard jar test to determine compatibility. **CHE-MAGNESIUM 2.5%** is most effective when placed in the root zone during planting or moved into the soil by irrigation. Do not use this product for foliar applications. It is important that the magnesium deficiency be treated before visual symptoms appear. Rates of application will vary depending upon the severity of the deficiency, climate and soil conditions. Use in accordance with label instructions and/or the recommendations of a qualified individual or institution such as, but not limited to, a certified crop advisor, agronomist, university crop extension publication, or apply according to recommendations in your approved nutrient management plan. Avoid applying this product when plants are suffering from moisture stress.

DIRECTIONS FOR USE

CHE-MAGNESIUM 2.5% can be applied to the soil alone or in combination with dry or liquid fertilizer. **CHE-MAGNESIUM 2.5%** is recommended to correct deficiencies in crops and ornamentals and designed for the following uses: (1) Mixing with liquid fertilizers for pre-emergence or post-emergence application; (2) Mixing with liquid fertilizers; (3) Application in irrigation water, either alone or in combination with fertilizers and/or pesticides; (4) Mixing with pesticide spray solutions for soil application; (5) Application either alone or as a component in other liquid mixtures where soil application is otherwise impractical.

Shake well before use.

APPLICATION RATE RECOMMENDATIONS

Mild Deficiency:	1-2 pints per acre
Moderate Deficiency:	3-4 pints per acre
Severe Deficiency:	5-8 pints per acre

Add **CHE-MAGNESIUM 2.5%** to the tank first when applied with a pesticide.

STORAGE & DISPOSAL

Store Above 32°F. If frozen, warm to room temperature and mix vigorously. Store this product in stainless steel, fiberglass, polyethylene, or certain other plastic materials. Copper or any of its alloys (brass or bronze) should never be used in any chelated handling system. Aluminum tanks are not recommended for storage of this product. Check with equipment manufacturer for compatibility of components prior to use of this product.

NOTE: Do not mix or contaminate any EDTA type chelates with strong acid. Store in a well-ventilated place. Keep container tightly closed. Store locked up. Dispose of contents / container in accordance with Federal, state and local regulations.
