FIRST AID

Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor or going for treatment.

Kicker Plus is a liquid ammonium sulfate and drift reduction agent designed to alleviate tank mix problems commonly associated with dry ammonium sulfate in addition to reducing the number of small driftable particles. When used as directed, *Kicker Plus* maximizes the activity and effectiveness of certain herbicides in post emergence applications. Therefore, care must be taken in treating sensitive crops during periods when plants are subjected to drought stress, high temperatures, and high humidity. SHAKE WELL BEFORE USING.
