SHAKE WELL BEFORE USE

FORTIFY is a water dispersible, nonionic spreader-sticker adjuvant that is formulated to improve the efficiency of a variety of pesticides by increasing droplet spreading and adhesion onto leaf surfaces. **FORTIFY** enhances efficacy of herbicide, insecticide, and fungicide spray applications. **FORTIFY** works by reducing water surface tension to increase coverage while forming a protective film to adhere active ingredients to the plant surface. **FORTIFY** improves spray droplet deposition and suppresses off-target drift by producing a more uniform droplet spray pattern. The sticking properties in **FORTIFY** help to reduce tendency for wash-off of the spray deposit caused

DIRECTIONS FOR USE

For use with products registered for agricultural, forestry, industrial, municipal, non-cropland, ornamental, rights-of-way, turf, and other uses. **NOT FOR AQUATIC USE.** **FORTIFY** may be used by ground or air applications.

Always read and follow instructions of the pesticide label regarding the use of an adjuvant. If the pesticide label does not specifically recommend, yet does not prohibit, the use of a spreader-sticker adjuvant, the applicator should conduct an advance phytotoxicity test using a small volume of tank mix combinations to confirm compatibility and plant safety.

MIXING INSTRUCTIONS

1. Water as indicated by pesticide / fertilizer label instructions
2. Pesticide
3. Agitate
4. Add **FORTIFY** last to the tank mix

Rates per 100 Gallons Spray Mix

Defoliants, Desiccants, Herbicides: 1 to 4 pints
Fungicides, Acaricides, Insecticides: 1/4 to 2 pints
Wettable Powders: 1/2 to 3 pints

In Concentrated Or Diluted Spray Applications: Use enough **FORTIFY** to allow for uniform wetting and deposition onto leaf surfaces without unnecessary run-off.

For Field Crop Applications: Use 1/4 pint to 2 pints per acre.

For Drift Suppression: Use at least 2 pints of **FORTIFY** per 100 gallons of spray mix to minimize off-target spray drift. Note: **FORTIFY** will not eliminate spray drift.

Off-target drift hazards vary with the type of pesticide and application conditions. **FORTIFY** improves spray deposition and suppresses drift by producing a more uniform spray pattern.

STORAGE AND DISPOSAL
