Factors affecting the retention level include the quality of the dry fertilizer, the level of dust within the dry fertilizer and the presence of liquid additives.

Humic acids may aid in micronutrient uptake.

## DIRECTIONS FOR USE

*VitaCrop B* is a micronutrient product designed to aid in crop establishment and plant growth.

As a general guideline, the retention rates of *VitaCrop B* on many common dry fertilizer blends range from 0.1 to 0.4% by weight. Liquid additives may increase the retention of *VitaCrop B*.

To determine the coating capacity of *VitaCrop B* on your dry fertilizer blends, always use a blend test. For additional information, consult with your local crop advisor.

**WARNING:** This product contains boron and should be used only as recommended. The use of this product on any crops other than those recommended may result in serious injury to the crop(s).
