## FIRST AID

*VERIMAX AMS-CA* contains water conditioning properties and a homogenized deposition agent designed to improve the precision of spray applications and reduce off-target drift. It is suitable for use on both conventional and transgenic crop varieties.

When used at labeled rates, *VERIMAX AMS-CA* will automatically optimize the angle of the spray pattern, as the spray exits the nozzle, to give maximum coverage of target surfaces while minimizing "pattern fringe" which contains the most driftable particles.

*VERIMAX AMS-CA* is intended for use as a tank-mix adjuvant where a deposition or drift control agent is required or recommended.

*VERIMAX AMS-CA* has been proven to increase glyphosate activity. This product also contains emollients which may improve absorption of herbicides into leaf surfaces.

*VERIMAX AMS-CA* also contains buffering and sequestering agents to adjust pH to a neutral range. *VERIMAX AMS-CA* may be used when the pesticide label recommends the use of a deposition aid or drift control agent. It is not intended as substitute for surfactants or crop oil concentrates.

## DIRECTIONS FOR USE

*VERIMAX AMS-CA* is intended for use with products registered for agricultural, horticultural, turf, ornamental, industrial, and non-crop use. *VERIMAX AMS-CA* should be added to the diluted spray solution prior to the addition of any pesticides.

Ground and Air Rates:

Normal Use: 2 to 3 quarts per 100 gallons of water

Hard Water: 3 quarts per 100 gallons of water

*VERIMAX AMS-CA* contains the equivalent of 2 pounds ammonium sulfate/gallon.

## STORAGE AND DISPOSAL
