FIRST AID

Call a poison control center or doctor immediately for treatment advice. Have the product container with you when calling a poison control center or doctor, or going for treatment.

IF ON SKIN OR CLOTHING: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.

IF IN EYES: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses if present, after the first 5 minutes, then continue rinsing eye.

PRODUCT INFORMATION

INVADE RST contains a distinct, high-quality combination of methylated soybean oil and organosilicone surfactant. The oil is a superior penetrant that aids certain pesticides in moving through the waxy cuticle of plants and leaves for greater efficiency. In addition, the organosilicone surfactant increases spreading and wetting of the applied solution so that the active moves to and through the plant quickly. Use *INVADE RST* wherever a label calls for an MSO or MVO and allows or does not exclude the use of an organosilicone.

DIRECTIONS FOR USE

INVADE RST is intended for use with products registered for agricultural, forestry, industrial, non-cropland, rights-of-way, and other uses. The use of *INVADE RST* can increase pesticidal activity where the following factors occur but is not limited to: (1) Low humidity and high temperatures; (2) Low water volume rates of less than 15 gallons per acre; and (3) When target species are larger than the label recommendations at time of application. **NOT FOR AQUATIC USE.**

APPLICATION RATES

Herbicides

Ground rates: ½ to 2 pints per acre in 10 to 20 gallons of spray solution.

Aerial rates: ½ to 2 pints per acre in 5 to 10 gallons of spray solution.

Insecticides

Ground rates: 4 to 16 ounces per acre in 5 to 10 gallons of spray solution.

Aerial rates: 4 to 6 ounces per acre in 2 to 5 gallons of spray solution.

Defoliants

Ground rates: 4 to 16 ounces per acre in 5 to 10 gallons of spray solution.

Aerial rates: 4 to 6 ounces per acre in 2 to 5 gallons of spray solution.

NOTE: The application rates on this label are based on pesticide labels which recommend the use of a nonionic surfactant. Rates of this product may be increased or decreased for optimum results, follow pesticide labeling for proper recommendations. Before using *INVADE RST* where a nonionic surfactant may not be recommended, the user or applicator advisor must have experience with the combination or must have conducted a phytotoxicity trial.

MIXING INSTRUCTIONS

Prior to pesticide application, clean mixing and application equipment according to pesticide label directions.

To Minimize Foaming: Fill spray tank 2/3 or 3/4 full of water and begin agitation. If Foaming Is Anticipated: The addition of an anti-foaming agent should be added before pesticides, nutrients, or *INVADE RST*.

Mixing Procedure: Add pesticides and/or fertilizers as directed by label or in the following sequence: (1) Micronutrients and fertilizers, (2) Dry flowables and dispersible granules, (3) Flowables, (4) Water soluble pesticides, (5) Emulsifiable concentrates. Continue agitation and add *INVADE RST*. When completed, reduce agitation and allow to mix for 1 to 2

minutes. While under minimal agitation, continue filling tank and allow to mix for 10 to 15 minutes prior to application.

NOTE: For optimum results, spray mixes containing *INVADE RST* should be applied within 36 hours.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Store in original container only. **DO NOT** add anything to the container. Keep container tightly sealed when not in use. **DO NOT** store near fire, flame or other potential sources of ignition. **DO NOT** contaminate water, food or feed by storage or disposal of this product. Shake well before using. If product freezes, allow to thaw, then shake well. For optimal storage, store between 40° and 90 °F.

DISPOSAL: DO NOT reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal if allowed by law.
